### Advance Directive Notification

In the State of Texas, all patients have the right to participate in their own health care decisions and to make Advance Directives or to execute Powers of Attorney that authorize others to make decisions on their behalf based on the patient's expressed wishes when the patient is unable to make decisions or unable to make decisions or unable to communicate decisions. Memorial Hermann Surgery Center Woodlands Parkway respects and upholds those rights.

However, unlike in an acute care hospital setting Memorial Hermann Surgery Center Woodlands Parkway does not routinely perform "high risk" procedures.

While no surgery is without risk, most procedures performed in this facility are considered to be of minimal risk. You will discuss the specifics of your procedure with your physician who can answer your questions as to its risks, your expected recovery, and care after your surgery.

Therefore, it is our policy, regardless of the contents of any Advance Directive or instructions from a health care surrogate or attorney-in-fact, that if an adverse event occurs during the your treatment at this facility, we will initiate resuscitative or other stabilizing measures and transfer you to an acute care hospital for

further evaluation. At the acute care hospital, further treatments or withdrawal of treatment measures already begun will be ordered in accordance with your wishes, Advance Directive, or health care Power of Attorney. Your agreement with this facility's policy will not revoke or invalidate any current health care directive or health care power of attorney.

If you wish to complete an Advance Directive, copies of the official State forms are available at our facility.

If you do not agree with this facility's policy, we will be pleased to assist you in rescheduling your procedure.

### Physician Ownership:

- ❖ There may be one or more of the physicians providing treatment at the Memorial Hermann Surgery Center Woodlands Parkway that has an ownership interest in the surgery center. Patients have a right to choose the provider of their healthcare services.

Please be aware that all doctors of medicine furnishing services to the patient, including the Anesthesiologist, Pathologist, Radiologist are independent contractors and are not employees or agents of this Surgery Center; this may include the use of independent laboratories who will all bill separately for their services.
